

ANTI-RAGGING POLICY BENGTOL COLLEGE, BENGTOL

Bengtol College maintains zero tolerance against ragging activities. The policy is based on the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009. The UGC Regulations have been framed in view of the directions issued by the Supreme Court of India to prevent and prohibit the menace of ragging in all Indian Educational Institutions.

Ragging constitutes one or more of the following acts:

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling any student with rudeness.

2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any other student.

3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such a student;

4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any student.

5. Exploiting the services of a student for completing the academic tasks assigned to an individual or a group of students.

6. Any act of financial extortion or forceful expenditure burden put on a student by other students.

7. Any act of physical abuse including all variants of it: such as, sexual abuse, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;

8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to any other student.

9. Any act that affects the mental health and self-confidence of any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any other student.

Anti-Ragging Measures:

1. All the requirements as per the regulations of the Central and State governments, UGC and court guidelines including anti-ragging undertaking by students and parents, awareness programs, etc. are satisfied.

2. The College strictly adheres to the provisions of the acts of Central and State Governments.

3. The Principal, Squad members and the Anti- ragging Cell of the College directly supervises.

4. The Anti-ragging Cell shall ensure strict vigilance on activities of students especially during the arrival of new batches in the beginning of the academic year.

5. The faculty members will help to identify potential violators and students with stress, tension and other troubles and personally meet them, and if necessary, take the steps to have sessions with professional counsellors.

6. Awareness cum orientation program is arranged for the newcomers in the beginning of the academic year in order to prepare them for the socio-academic life in the campus.

7. The College identifies all vulnerable locations, and ensures a constant vigil and watch at such locations within the college premises.

8. The institution ensures the participation of all the students during freshmen social day and organized different activities to erase the feeling of senior- junior distinctions among the student community.

Anti-Ragging Cell

The Anti-Ragging Cell, as constituted by the IQAC and headed by a Chairman (Principal) who examines all complaints of anti-ragging and initiate with recommendation based on the nature of the incident.

Structure of the cell

1. Tenure of the cell members and squad two years, can reappoint for another terms.

2. Total strength of the Body with six members.

3. Discipline teacher in-charge of the union body of the student generally become a member of the cell.

4. All plan and policies of the cell are implemented equally.

A student found guilty by the cell will attract one or more of the following punishments, as imposed by the Anti-Ragging cell:

1. Suspension from attending classes and academic and co-curriculum activity.

2. Debarring from appearing in any test / examination or other evaluation process.

3. Withholding results.

4. Suspension/ expulsion from the hostels and mess.

5. Cancellation of admission.

6. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

7. In cases where the persons committing or abetting the act of ragging are not identified, the College shall resort to collective punishment.

8. If need be, in view of the conditions of the act of ragging cell, a First Information Report (FIR) shall be filed by the College with the local police authorities.

9. The Anti-Ragging Committee of the College shall take appropriate decision, including imposition of punishment, depending on the facts and circumstances of each incident of ragging and nature and gravity of the incident of ragging.

As it has been mentioned we have come to know that ragging is a serious crime that jeopardizes career of a student or even takes the life of many students, as ragging related incident show us. Therefore, it's the duty of all the stakeholders including the students to make a ragging free culture for healthy teaching learning environment in all academic institutions
